INTRODUCTION

1.1 ABOUT THIS MANUAL

The ELAA *PolicyWorks Manual – National Quality Framework v2* provides information and resources to assist early childhood education and care services develop and update policies and procedures to meet legislative, regulatory and funding requirements. It is available online in a convenient downloadable format. This manual has been fully updated to incorporate the requirements of the new *Education and Care Services National Law Act 2010* (National Law), *Education and Care Services National Regulations 2011* (National Regulations) and the *National Quality Standard* (NQS).

The National Regulations list policies and procedures required for all service types (Regulation 168). PolicyWorks Manual - National Quality Framework v2 contains a sample of each of the policies mandated by legislation. It also contains samples of additional operational policies considered by ELAA to be best practice for education and care services. Within the manual, policies are labelled either Mandatory or Best Practice for clarity. Individual services will need to decide which of the Best Practice policies to adopt. All sample policies should be amended to reflect individual service philosophy, needs, practices, beliefs and values. Some sample policies (e.g. Delivery and Collection of Children Policy) may also require a service specific decision to be made - this information is highlighted within the document. ELAA recommends that any changes made to the templates be checked against all relevant legislation and regulations to ensure compliance. There may also be other specific policies that services identify as necessary in the context of their particular situation. Information about the policy development process and a standard policy template is included in this manual to develop these where required. Industrial policies are not included in this manual - refer to ELAA's Early Childhood Management Manual (ECMM) under Resources in 1.3 below.

The sections of this manual correspond to the seven Quality Areas of the *National Quality Standard*. The Regulatory Overview Table lists the

quality area, standards and elements, detailing related policies, practice requirements and guidance notes. The table also includes reference to related laws, regulations and curriculum framework principles for each Quality Area, standard and element and an indication of which areas to consider in developing a service philosophy. Policies can be arranged alphabetically within each Quality Area. ACECQA's Guide to the Education and Care Services National Law and the Education and Care Services National Regulations 2011 and Guide to the National Quality Standard have been used extensively in the preparation of these policies. This manual has been designed to be used alongside these guides.

1.2 NATIONAL QUALITY FRAMEWORK

The National Quality Framework for Early
Childhood Education and Care (NQF) commenced
on 1 January 2012 with the aim of providing every
Australian child with the best start in life through
access to high-quality early childhood education
and care, and school-age care services. The NQF
is designed to assist providers to improve the quality
of services and enable families to make informed
decisions about the best service for their child.

The National Quality Framework includes1:

- a national legislative framework that consists of the National Law and National Regulations
- · a National Quality Standard
- · an assessment and rating system
- a regulatory authority in each state and territory with primary responsibility for the approval, monitoring and quality assessment of services in their jurisdiction in accordance with the national legislative framework and in relation to the National Quality Standard. In Victoria, the Department of Education and Early Childhood Development will take on the regulatory role
- the Australian Children's Education and Care
 Quality Authority (ACECQA). This national body is
 responsible for providing oversight of the system
 and ensuring consistency of approach.
